



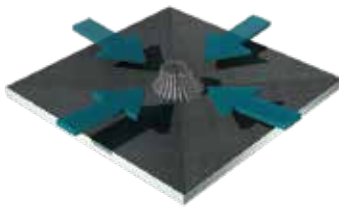

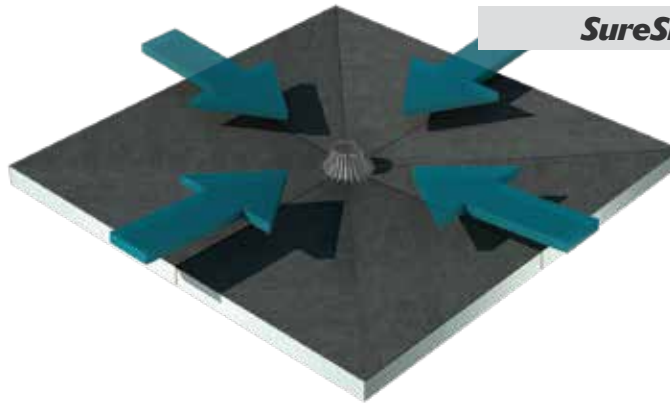

The dimensionally stable SureSlope DST provides a positive 4-way slope to the roof drain.

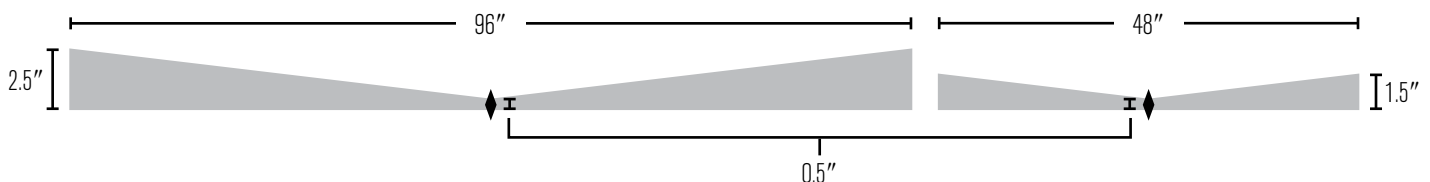
